C I R C U L A R

It is with great pleasure to announce that after considering requests of the Members, the Managing Committee in its meeting held on 6th March 2019 under the Chairmanship of Shri Raj Purohit, Vice-President, has decided to introduce various schemes for Membership/ Associateship and other important decisions/changes/modifications/ arrangements which are mentioned as under :-

ENROLLMENT OF 3RD CHILD (Ordinary Membership for Son/ Daughter of Ordinary/Life Members)

Managing Committee has considered to enroll even the 3rd Child of Ordinary/Life Member.

- i. An Ordinary/Life Member of the Club House with 8 years of Standing / Active Membership can make a request for the Ordinary Membership under Member's Son/Daughter Category for his/her **THIRD** Son/Daughter. In case of Son, on attaining his age of 18 years and before the completion of 21 years of his age and in case of Daughter, on attaining the age of 18 years and within One Year of her Marriage.
- ii. The prescribed Request Form will be available from the Club House Office during Club House Office working hours.
- iii. On receipt of the "Request Form" duly filled in alongwith proof of the age, Club House Office will scrutinize and on finding the form in order, the Club House will send a letter for further procedure.
- iv. The Entrance Fee of Rs.5 Lakhs + 18% GST, totalling to Rs.5,90,000/- or the Entrance Fee prevailing, from time to time, shall be applicable.
- v. The Entrance Fee will be payable in four Equal Six Monthly Installments alongwith the prevailing rates of GST as applicable on receipt of the letter from the Club House.
- vi. The First Year Subscription shall be Rs.24,000/- + 18% GST and from the subsequent year Rs.8,000/- + 18% GST or prevailing from time to time and Contribution for Property Tax of Rs.3,000/- + GST per annum shall be applicable.
- vii. Only three Candidates either Son/Daughter will be considered, taking into account, enrollment of Son/Daughter in the past provided that the Member concerned has been a Member of the Club House for minimum period of Eight years and subject to minimum one year gap between the enrollment of two Applicants.
- viii. The date of receipt of the Application Form by the Club House, will be considered, for ascertaining the eligible age.
- ix. The Proposer must be either Father or Mother, whoever is a Ordinary/ Life Member of the Club House and their Membership should be active.
- x. Entrance Fee paid will not be refunded, in case of cancellation or in default in paying Entrance Fee within stipulated time.
- xi. The enrollment of third child shall be governed under Memorandum and Articles of Association and Rules of the Club House in force from time to time.

AMNESTY SCHEME : (Ordinary Membership for Son/Married Daughter above 21 years of age and before Completion of 60 years of age)

- I This Amnesty Scheme is applicable for the Son/Daughter of Ordinary/Life Member, who has missed the opportunity for applying for the Ordinary Membership under Son/Daughter category on or before completion of 21 years of age in case of Son and in case of Daughter, not applied for said Membership within one year of Marriage.
- ii. **Eligibility :** Sons/Married Daughters , who have completed the age of 21 years but before the completion of 60 years age shall be eligible under this scheme.
 - iii. The Entrance Fee is Lumpsum Payment of Rs.10,00,000/- + 18% GST. No Installment facility is applicable.
 - iv. The First Year Subscription shall be Rs.24,000/- + 18% GST and from the subsequent year Rs.8,000/- + GST or prevailing from time to time and Contribution for Property Tax Rs.3,000/- + 18% GST.
 - v. Only Three Candidates either Son/Daughter will be considered, taking into account, enrollment of Son/Daughter in the past provided that the Member concerned has been a Member of the Club House for minimum period of Eight years.
 - vi. The Application Form will be available on payment of Rs.100/- from Club House Office during the Office Working Hours.
 - vii. On receipt of the Application Form, alongwith required documents, Club House Office will scrutinize the same and on finding the said Form in order, the Club House will send the letter for further procedure.
 - viii. Entrance Fee paid will not be refunded, in case of cancellation or in default in paying Entrance Fee within stipulated time.
 - ix. The Issuance and Acceptance of the Application Form will be from 2nd May, 2019 to 31st July, 2019 from the Club House Office, during Office Working Hours from Monday to Friday between 11.00 am to 2.00 pm & 2.30 pm to 6.00 pm and on Saturday between 10.30 am and 1.30 pm.
 - x. The entire Scheme will be governed under Memorandum and Articles of Association and Rules of the Club House in force from time to time.

MEMBER'S FRIENDLY SCHEME : (Ordinary Membership for Son/Daughter above 10 years and before completion of 18 years of age)

- i. Ordinary/Life Members of the Club House with 8 years of Standing/ Active Membership can avail "Member's Friendly Scheme" facility and make a request for the Ordinary Membership for their Sons/Daughters on attaining their age of 10 years and before the completion of 18 years of their age.
- ii. The prescribed form under "Members Friendly Scheme" will be available from the Club House Office during Club House Office working hours.
- iii. The prevailing Entrance Fee of Rs. 5 Lakhs + 18% GST will be applicable.
- iv. The Entrance Fee will be payable in four Equal Six Monthly Installments alongwith the prevailing rates of GST as applicable. First Installment of Entrance Fee alongwith the prevailing GST as applicable, is payable on receipt of Club House letter in response to the Member's Friendly Scheme Form.
- v. Only Three Children either Son/Daughter will be considered, taking into account, enrollment of Son/Daughter in the past provided that the Member concerned has been a Member of the Club House for minimum period of Eight years and subject to minimum one year gap between the enrollment of two Applicants.
- vi. The Proposer must be either Father or Mother, whoever is a Ordinary/ Life Member of the Club House and their Membership should be active.
- vii. Entrance Fee paid will not be refunded, in case of cancellation or in default in paying Entrance Fee within stipulated time.
- viii. The Application Form will be available on payment of Rs. 100/- from Club House Office during the Office Working Hours.
- ix. On receipt of the Application Form, alongwith required documents, Club House Office will scrutinize the same and on finding the said form in order, the Club House will send the letter for further procedure.

- x. The Membership of the Ordinary/Life Members should be active while enrolling their Son/Daughter as Ordinary Member, under the Scheme, on attaining the age of 18 years, otherwise the request made for the Scheme will be automatically cancelled immediately and Entrance Fee paid will be forfeited.
- xi. On complying with all the procedures, the son/daughter will be automatically enrolled as Ordinary Member on attaining the age of 18 years and he/she will have to pay Annual Subscription at the prevailing rate and GST, thereof for the said Financial Year.
- xii. The Issuance and Acceptance of the Application Form will be from 2nd May, 2019 to 31st July, 2019 from the Club House Office, during Office Working Hours from Monday to Friday, between 11.00 am to 2.00 pm & 2.30 pm to 6.00 pm and on Saturday between 10.30 am and 1.30 pm.
- xiii. The date of receipt of the Application Form by the Club House, will be considered, for ascertaining the eligible age.
- xiv. The entire Scheme will be governed under Memorandum and Articles of Association and Rules of the Club House in force from time to time.

SURVIVING SPOUSE ASSOCIATESHIP:

Existing Rule for making an Application for Surviving Spouse Associateship by the Spouse of the Ordinary / Life Member within 3 years from the date of sad demise of the concerned Member has been replaced with the following :

- Surviving Spouse of Ordinary/Life Member can apply for 'Surviving Spouse Associateship' any time after sad demise of Member.
- The Surviving Spouse of the Ordinary/Life Member, whose Spouse Member has expired on or after 1st January 2001, can also make Application for the 'Surviving Spouse Associateship' .

TEMPORARY ASSOCIATESHIP :

Members/Associates can introduce their Guest/s as Temporary Associate for the period not exceeding 1 year. The terms and conditions are as under :-

- Any person introduced by the Club House Member may be admitted by the Committee as a Temporary Associate for the period not exceeding one year.
- The desirous person for Temporary Associateship should be introduced by the Club House existing Member.
- The tenure of one year can be extended by the Club House Committee on receipt of requisite Application.
- Entrance Fee of Rs.2,00,000/- plus GST.
- Annual Subscription of Rs.15,000/- plus GST
- Refundable Interest Free Deposit of Rs.25,000/-.
- Son/Daughter of Temporary Associate upto the age of 18 years shall be eligible to use the Club House facilities.
- Temporary Associateship shall be governed by the Memorandum and Articles of Association and Rules of the Club House in force and applicable from time to time.
- Application Form will be available from the Club House during its working Hours on payment of Rs.100/-.

ORDINARY MEMBERSHIP :

Ordinary Membership is open at present. Members can take this opportunity to introduce their Friends or Family Members for Ordinary Membership on payment of Entrance Fee Rs.25 Lakhs + 18% G.S.T. The Application Forms will be available on payment of Rs.100/- from Club House Office during the Office Working Hours.

Corporate Associateship for Corporate Companies is open at present. The details are as under :-

Unisex Salon facilities, at Fahrenheit Salon LLP are available to our Members on 3rd Floor of Phase II Building, from 9.00 a.m. to 8.00 p.m.

SWIMMING POOL :

- The Swimming Pool Timings for the Adults are extended upto 12.30 noon instead of 12.00 Noon earlier.
- The Swimming Pool Timings for the Children during Summer Vacation upto 16th June, 2019 are revised upto 11.00 a.m. instead of 10.00 a.m. and in the Evening Session upto 7.30 p.m. instead of 7.00 p.m.
- Guests are not permitted on Saturdays, Sundays and Bank Holidays during Summer Vacation upto 16th June 2019.

HEALTH CLUB :

The Health Club timings are revised upto 1.30 p.m. instead of 12.30 p.m. earlier and in the evening session from 3.30 p.m. instead of 4.00 p.m.

GUEST ENTRY CHARGES :

- No Guest Charges will be levied between 11.00 am and 3.00 pm at the Main Reception for visiting Swaad and Fine Dine Restaurants and Onyx Bar.
- From 7.00 am to 11.00 am and 3.00 pm to 11.00 pm, Single Guest Entry Charges of Rs.75/- (incl.GST) will be applicable for visiting Swaad and Fine Dine Restaurants, Onyx and Lounge Bars.
- However, for availing other facility, the usual Guest Entry Charges of respective section shall be applicable.
- On Fridays, Saturdays, Sunday and Bank Holidays usual Guest Charges will be applicable.
- The revised charges shall be applicable initially for the period of 3 months from 18th April, 2019 to 17th July, 2019. Subsequently, the Committee may review the decision.

CATERING :

Recently, more items are added on the Menu of Swaad Restaurant and ONYX Bar, run by M/s. Superior Hospitality Services and on the Menu of Coffee Shop / Fine Dine Restaurant and Lounge Bar, run by M/s. Udhan Hospitality Pvt. Ltd. (Gymkhana 91)

DRESS CODE :

- Attires like Shorts, Bermudas, Three Fourths, Sleeveless Tops, Singlets, Gym Baniyan (applicable to Gents) and Footwears like Bath/Rubber Slippers are NOT ALLOWED in the Swaad Restaurant, Onyx Bar, Lounge Bars and the Fine Dine Restaurant.
- However, Dress Code for using Swaad Restaurant is relaxed in the Morning Session between 7.00 am and 11.00 am & Evening Session between 4.00 pm and 7.00 pm and there is no restriction for Children below 12 years.
- Only appropriate attire/footwear for availing Sports section facilities i.e., Tennis, Table Tennis, Billiards, Squash, Virtual Golf and Badminton are to be worn/used.
- Jeans, formal Apparel, formal Shoes, Slippers or barefoot are not allowed in the Sports section.

INTRODUCTION OF GCH MOBILE APP :

Garware Club House introduces GCH Mobile App powered by M/s.IRCA India (P) Ltd., by which you can watch your Membership Account through GCH Mobile App by following the below mentioned steps:-

- **STEP 1** : Download eclub (CMS)  Mobile App powered by IRCA India (P) Ltd from Android Play Store or IOS Play Store. For iPhone Mobile, App is Ircaapp
- **STEP 2** : Membership No is USERNAME with the prefix gch. _____ f the Membership Number is S12345. For example : USERNAME : gch.S12345.

Date of Birth is Password without any delimiters like '-' or '/'. For example : If date of birth is 27-10-1982 then the PASSWORD will be 27101982.

In the isolated cases, where Date of Birth is not updated on the GCH System, then the Default Password will be 01011900.

If Member forgets the Password OTP will be sent on his/her Registered Mobile Number.

- For any assistance in using the Mobile App, kindly contact Club House Office during its Office Working Hours.
- Very Shortly, Members can make the Bill Payment through Mobile App.

IMPLEMENTATION OF NEW WEB BASED SOFTWARE

The Club House has introduced new ERP Solution/Web Based Software for Club House i.e., "IRCA ICMS Application" from M/s.Integrated Risk Control Applications Pvt.Ltd (IRCA).

Members are requested to please take note of the above and kindly co-operate with us, in case of any inconvenience faced, during transitional period of the introduction and migration to the new Software.

Very shortly, Members shall be able to book Rooms/Suites, Banquet Halls, Private Party Halls, Sports Coaching Registration and Massage through new Web Based Software and Mobile App, without visiting the Club House. The information in this regard will be shared with the Members accordingly.

RFID (IDENTITY) CARDS

RFID Cards will be issued to all the Members and their family Members by the Club House shortly. The Members will be intimated individually for collecting the same from the Club House.

BILLING SYSTEM

As per the new Rules and Norms of GST, a Bill once generated cannot be edited or cancelled, hence the Members are requested to comply with the directions mentioned below :-

- i. Members/Associates have to confirm their Guest Count before the detail are entered in the system by the staff at the Main Reception and concerned section they would be visiting / utilizing.
- ii. Members/Associates have to inform their Membership Number before placing order in the Restaurants/Bar.
- iii. Members must check the Billed items before settlement.
- iv. Members should confirm Pay Mode before final Bill settlement.

MEMBERS ARE ALSO REQUESTED TO CARRY THEIR LAMINATED IDENTITY CARDS DURING THEIR VISITS TO THE CLUB HOUSE AND PRODUCE THE SAME ON DEMAND. IN ABSENCE OF THE IDENTITY CARD, THE CONCERNED MEMBER/ASSOCIATES AND THEIR FAMILY MEMBERS WILL NOT BE PERMITTED TO USE ANY OF THE CLUB HOUSE FACILITIES.
