- a) Duration of Massage will be for 30 minutes on one Table & 60 minutes on another Table. However, booking for Massage for 30 minutes can be made on the table meant for 60 minutes' duration.
- b) Please note that on weekly off of the Masseur, the duration of the Massage will be only for 30 minutes.
- c) The charges for Massage are:-  
**For Members**  
i) 30 minutes Massage - Rs.125/- + GST and  
for 60 minutes Massage - Rs.250/- + GST.  
**For Guests**  
ii) 30 minutes Massage - Rs.175/- + GST and  
for 60 minutes Massage - Rs.350/- + GST.
- d) Advance booking for Massage can be done 3 days in advance for e.g. booking of 29<sup>th</sup> April'2022 can be made on 26<sup>th</sup> April'2022. Booking on phone will not be accepted.
- e) Members/Associates will have to sign on the Register maintained at the Health Club for the advance booking of the massage.
- f) Beyond the time of booking for the Massage only 5 minutes' grace will be given to the members, who has booked the Massage & failing which another member will be given the chance for Massage. In such case, the member who has failed to turn up for Massage, will be charged Massage charge for the period of 30 minutes' Massage or 60 minutes Massage he has booked.
- g) For cancellation of the Massage booked by the member/associate, the concerned member/associate will be required to inform in writing about the cancellation of the Massage 24 hours before the date and time of the Massage booked for.

Members/Associates are requested to note the above.
