

TERMS & CONDITIONS

TICKETS FOR T20 MATCH TO BE PLAYED AT WANKHEDE STADIUM BETWEEN INDIA AND SRI LANKA ON 3RD JANUARY, 2023

1. The Application Form duly filled in and signed by the Members/Associates will be received by the Club House on production of Identity Cards of the Members/Associates concerned on Special Counter opened for the purpose at the Main Reception of the Club House Phase II Building upto 10.30 pm, on 28th December, 2022. Please ensure that the form is signed by Member/Associates as per his specimen signature in the Club House record. In case of mismatch of Signature, the form may be rejected.
2. On receipt of the Application Form by the Club House, the Members/Associates will be issued Acknowledgment Slips against the receipt of the form by the Club House which has to be preserved carefully.
3. The Tickets will be allotted by Computerized Draw, taken out on 29th December, 2022 at 3.00 pm., in the Banquet Hall No.4.

The notification about allotment of Tickets after Computerized Draw will be displayed in the Club House premises on 29th December, 2022 by 6.00 pm. The Members/Associates themselves will have to check the same about allotment of Tickets displayed in the Club House premises personally. No other intimation, in this regard shall be given.

CANCELLATION OF TICKETS ALLOTTED WILL NOT BE PERMITTED UNDER ANY CIRCUMSTANCES.

4. The Forms may be accepted from Members/Associates after the Computerized Draw is taken out on 29th December, 2022, subject to availability of tickets. The tickets for such application will be issued from amongst the available balance tickets.
5. (a) Ticket/s if allotted, will be issued to the Members/Associates in exchange of the said acknowledgment slip, on production of their Identity Card and against Cash Payment or payment by Credit/Debit Card only, from the Special Counter to be opened for the purpose on **Saturday, 31st December, 2022** and **Sunday, 1st January, 2023** between 9.00 am and 6.00 pm except Lunch Break between 2.00 pm and 2.30 pm.
- (b) The Representatives of the Members/Associates will have to produce Identity Card of the Members/Associates alongwith the prescribed Letter Of Authority, issued alongwith the Form, for the collection of the Tickets.
6. Each Member/Associate will be issued maximum **FOUR (4)** Tickets including Tickets for the Members/ Associates, their family Members and/or their Guests, subject to availability. However, if the demand for the Tickets is more, the Management reserves the right to reduce the allotment of number of tickets per Member.
7. Application only for Guests will get a lower priority than an application for a Member and his Guest(s). Allotment of tickets for Guest will be made only if tickets are available after allotment to Members/Associates. The Tickets may not be issued together, since the allotment will be by Computerized Draw.
8. Application for issuance of Tickets for the "Associates enrolled through Mumbai Cricket Association" as per Memorandum Of Understanding dated 6th March, 2005, will not be considered.
9. MEMBERS/ASSOCIATES SHALL PRODUCE CLUB HOUSE LAMINATED IDENTITY CARD ISSUED TO THEM AND THEIR VALID TICKET/S, AS AND WHEN DEMANDED DURING THE PERIOD OF THE MATCH.
10. THE MEMBERS/ASSOCIATES WILL NOT BE ISSUED TICKETS IF THEIR CLUB HOUSE DUES AS ON 31ST MAY, 2020 ARE NOT PAID BY THEM.
11. THE MEMBERS/ASSOCIATES, WHO HAVE NOT SUBMITTED THE KYM FORM SHALL NOT BE ELIGIBLE TO APPLY FOR TICKETS.
12. In case the Ticket/s allotted to the Members/Associates and not collected within the above mentioned stipulated time limit, the price of the Ticket and GST charge for the same will be debited to their Membership/Associateship account with the Club House.
13. All areas of activities of the Club House will remain suspended on Match day for entire day. Parking will not be available on 2nd and 3rd January, 2023.
14. The Application Forms duly signed by the Member and sent through Club House email : info@garwareclub.co.in within the prescribed time limit i.e., upto 10.30 pm, on Wednesday, 28th December, 2022 will also be accepted.
