- c] If Membership No. is C12345 then your Fourteen digit Virtual Account No. will be GCMZ0000C0012345.

MEMBERS PLEASE NOTE THAT THIS ACCOUNT IS TO BE USED SOLELY FOR THE PURPOSE OF PREMIUM PAYMENT FOR THE GROUP MEDICLAIM POLICY AND NOT TO BE USED FOR PAYMENT OF CLUB HOUSE DUES. POLICY SHALL NOT BE ISSUED IF THE PAYMENT IS INCORRECTLY MADE TO THE CLUB DUES A/C.
